# MONITORING AND OVERSIGHT TOOLS

(Presented by Bangladesh & Secretariat)

#### **SUMMARY**

This Paper presents an update on the Monitoring Tools for tracking of SEI and NASP Implementation in line with the GASP and AP-RASP. And States/Administration's may have a look on the Oversight Tools developed by Bangladesh with the guidance of APAC RO. Such automated tools shall add to the capacity building effort of the APAC Region in terms of Monitoring and Oversight capability of aviation safety and security.

Action by the Conference is at Paragraph 3.

#### MONITORING AND OVERSIGHT TOOLS

#### 1. INTRODUCTION

- 1.1 The Monitoring Tools was initiated in 2014 with the support of Bangladesh and launched in 2016. The tool was further updated 2022 after the APRAST and RASG-APAC Decisions for tracking of SEI and NASP Implementation in line with the GASP and AP-RASP. The Tools was made LIVE in 2023 with all updates.
- 1.2 While developing the Monitoring Tools, side by side, Bangladesh took initiative coordinating the APAC Regional office on the Safety Oversight Tools for State's CAA/NAA which basically focuses on the ICAO eight Critical Elements (CE-2 to CE-8) and Critical Areas addressing the USOAP CMA Protocol Question outcome and many other features to run the CAA Oversight System through an integrated software tools.

#### 2. DISCUSSION

- Monitoring Tools software initially was developed by Bangladesh to monitor the implementation progress of the SEIs for all APAC States/Administrations through the APRAST Conclusion 5/7, RASG-APAC 4/23 and APRAST Decision 6/3. The application was hosted LIVE in ICAO-APAC Website till 2019. Later, it was decided through the Decision RASG/APAC 9/6, 10/8 and Task-4 of Yearly Work programme 2020-21 to upgrade and enhance the scope of the Monitoring Tools tracking to include the NASP development and implementation in line with AP-RASP and GASP through a mapping mechanism. Bangladesh further volunteered and completed the job by end 2021. The Monitoring Tools can be accessed through an independent link (<a href="https://monitoringtools.org/monitoring-tool/">https://monitoringtools.org/monitoring-tool/</a>) and passwords administered by the State/Administration Focal Points.
- 2.2 Bangladesh in coordination with ICAO APAC RO has further developed a Safety and Security Oversight Tools which is universal in nature to be used for many different modules. It addresses all eight ICAO Critical Elements including features to face an ICAO and FAA Audit. Details of the Modules are in **Attachment-1** to this WP and will be shown a LIVE Demo.




Figure 1: Overview of the Modules of the Oversight Tools

# CIVIL AVIATION SAFETY & SECURITY OVERSIGHT SOFTWARE

The Software is uniquely capable to support all kind of Civil Aviation Certification, Licensing, Computer Based Tests/Exams (CBT), Flight Safety Inspectors Training System (ITS), all types of Surveillance-Inspections-Audits (SIA), Findings and Corrective Action Plan by the Industry, Closure of all Findings including Legal Actions, Resolution of Safety Concerns, ICAO USOAP CMA PQ Management, All Aircraft Information details under the State CAA, ICAO Compliance Check List with Electronic Filing of Difference (CC/EFOD) process, Administering the State Letters and ICAO Amendments, Documentation and Record Keeping with Alerts System in the relevant Modules.

The five phases of Certification is an important module where Certificates like; Air Operators Certificate (AOC), Aircraft Maintenance Organization (AMO), Approved Training Organization (ATO), Aerodrome Certification etc needs to be automated to implement the ICAO SAPRPs and administer the CAA Regulations effectively.

The software is customizable for the Security Oversight System including the ICAO USAP Audit Protocols and CE-1 to CE-8 Management under Aviation Security (AVSEC).

The Software is capable to carry out the Accident investigation under AIG from Occurrence to Notification to Safety Recommendations too.

Many CAAs currently do the similar tasks manually in isolation which consumes huge man-hour and complex outcome. The Software aimed to mitigate the current challenges augment efficiency of CAAs in manifold.
