

RASG-APAC/12 Meeting - Overview

- 12th RASG-APAC Meeting was held in Hybrid mode from 17-18 November 2022 (majority participants attended online).
- 162 participants attended from 18 Member States and 09 International Organizations.
- Meeting adopted **12** Decisions based on **32** WPs presented.

A41 Outcomes

Secretariat to issue State Letters about ICAO GASP, RASP & NASP & invite sharing of SSP examples with ICAO. [Issued in May]

APAC Annual Safety Report 2023

Scheduled for publish on 28 Oct 2023.

APAC Regional Aviation Safety Plan 2023 - 25

Secretariat to arrange publish after GASP and final alignment needed *[Published]*

SSP Implementation / Safety Culture Workshops

Secretariat to organise workshops to facilitate sharing of experience and lessons learnt in this region. [1 Seminar conducted in Aug]

RASG-APAC Challenges and Focus

- APAC EI Level (65.31%) still below Global Average (68.88%).
 30.8% of APAC States achieved the GASP target (i.e. 75% EI).
- Needs of Pacific Small Islands Developing States (PSIDS) to be addressed & the Pacific Islands Aviation Plan (PIAP) Road Map to be executed.
- Implementation of SEIs in AP-RASP for 2023-2025.
- Implementation of SSP.

RASG-APAC Challenges and Focus (Cont'd)

- Implementation of NASP. Only 15 States uploaded their NASP in ICAO website from 39 APAC States.
- Training Capacity Building for developing qualified human resources. El for CE-4 is only 53.61%.
- Establishment of independent Accident Investigation Authority (only 40% of APAC States) and EI in AIG is only 47.76%.
- Achievement of Beijing Declaration Commitments.



PIRG and RASG Regional Coordination

- Consolidated Report on APANPIRG/33 and RASG-APAC/12 (April 2022 -March 2023) prepared by ICAO APAC Office was jointly presented by the President of ANC & Director, ANB to Council – 228th Session [AN-WP/9669 and C-WP/15487].
- Air Navigation Commission noted the excellent coordination between APANPIRG and RASG-APAC even with resource constraints [C-WP/15487 Appendix A Para 1.6 in Page A-20 refers].
- RASG-APAC and APANPIRG Chairs had a coordination meeting end of August 2023 where RASG Chair visited Regional office physically.
